# Reflections

It is like no other gift. No wrapping that glitters, no ribbon or bow. No tassels or decorations. The size changed as it was turned, large in places, small in others. The weight of it could not be judged, in some ways it was lighter than a feather, in others heavy, solid and dense. This gift did not beg to be opened, yet it seemed to open and close at will.

The gift comes in the darkness of desolation and loneliness. It comes in the night that seemed never ending, the restlessness of not being anywhere - and anywhere else would be the same. It speaks of the need of each person to love, be loved, to be beloved.

The gift comes in seeing the anguish of a man, a child, a woman, suffering the losses that

strike through the heart, thrown into the despair of unknowing. The gift nurtures the endurance of the spirit and the triumph of survival.

The gift comes in the willingness to be present to tears of frustration and emptiness, ours and those of others. Each drop cleansing the hurts, and opening the way of healing. It carries the pain of one person which, when so freely shared, allows the pain within the other to be touched; this pain which never completely leaves us but which shapes us, and oftentimes is the reminder that we exist. And while we each bear our own burdens, when we take on the burdens of another the two become lighter.

The gift comes in the realization of the pride carried within that destroys the good that could be done; pride that blinds us from seeing beneath the glittering image we strive to portray; pride that fortifies the walls

that shield us from being known by others, the fear of rejection. The gift brings forth the means to see that each one of us has our image and our essence, each constantly struggling to integrate the two sides of the true "us." It is not the rejection of others that we fear, but the rejection of ourselves.

The gift came in finally seeing the crippled man struggling to walk. Each day the cars go by so quickly that a passing glance is not even given: no one to encourage each careful step, aided by crutches, eyes looking forward as he makes his way. In the seeing came the appreciation of abilities taken for

granted. In the seeing came the realization of the many ways the physical body is abused and ignored. The Gift.

The gift comes in the realization of the pain caused by words spoken hastily, however kindly meant, that increased the isolation of another. The pain that is present when feelings are not understood or even acknowledged. The gift helps us become silent and present so that in the recognition of our failures we learn that true triumphs are not heralded from without, but glow from within.

The gift is in the gaze of the dying person, seeing beyond and within, seeing that which is hidden to those who try so hard, yet so obvious to those who no longer have to pretend. The gift is the briefest glimpse into the unknown, the gazing upon the self, the awareness that we are what we are, yet we are so much more.

The gift comes as weary arms open to



embrace and, taking a risk to be vulnerable, we walk into the solace that is both offered and needed. The giving and the taking, the softness and strength, the warmth of the body and the breath of life, freely shared so that each may be newly created.

The gift comes in the hurts and the pain that are universal yet unique to each person. When peace and love seem absent and the joys that were once shared are only memories whose intensity we fear. The gift is in the intermingling of the experiences of our life so that we become fully alive, we become complete, total, grow beyond our limitations.

The gift is ever present in our life. It is the Gift of Humanity and Humility, the Gift of Triumphs and Tragedy. It is a gift which grows with us and changes us. There is no earning or deserving of this gift, we cannot buy it nor wrap it, we cannot save it nor spend it. We can never use it up or replace it. It is given to others through us, yet it is also given to us through others. It is given to all yet is appreciated and known at different times by each individual. Sometimes it is rejected, sometimes embraced as the answer to prayers. No bow, paper, glitter or ribbon. The Gift. It shines bright when we take the time to see, not with our eyes but through the depth of our very being.

# A tribute to Dr. Lucian Fletcher, Jr. • 1923 - 2016

The community of Sussex County, NJ was sadden by the death of their beloved doctor, friend and mentor.

I met Dr. Fletcher (Lu) in 1980. My beloved husband Joe and I had just established the Karen Ann Quinlan Hospice in Newton, NJ. Little was known about Hospice, a new concept of caring for patients in their last stage of life. It was a learning process for doctors, nurses, aids, and the community. Lu was one of the first

doctors to embrace hospice and joined the Governing Board in early 1981 and remained an active member for the rest of his life.

He loved life, family and country. When he was accepted to Princeton University he joined the USN-V-12 Program during World War II and attained the rank of Lt.j.g.

At the outbreak of the Korean War, he enlisted in the USAF and was posted to Iwo Jima, Guam, and Okinawa, among others. In 1952, as Capt. Fletcher, he was appointed assistant chief of medicine at the USAF Hospital at Tachikawa AFB, Japan.

After the war he settled in Sussex County where he practiced cardiology and internal medicine.

Lu was an accomplished pilot, skier and dancer. He and his wife Connie opened their beautiful home to hospice on many occasions. Connie, died 1989. Years later he met and married Dottie, together they embraced the hospice and once again opened their home to hospice. Dottie and his loving family were present at the hour of his death.

He died peacefully in the hospice that he loved and nurtured for over thirty years. His life was a life of service to his country and

NEWTON - Under Medicare five percent of all hospice patient care hours must be provided by trained volunteers. This requisite emphasizes the important role that hospice volunteers play in caring for those with life-limiting illness and their family.

The trained volunteer brings dignity to the patients while providing support for the caregivers.

Sue Dougherty, the volunteer coordinator for Karen Ann Quinlan Hospice holds volunteer hospice training classes three time a year in different areas. The classes are four weeks long, two mornings per week and are held in September for the Newton area, November for the Milford, PA area and every March in Hackettstown. Anyone who wishes to dedicate time as a volunteer may sign up for any of the area classes.

It is advised that to be an active patient volunteer, the individual should not have experienced a significant loss within the past year. Volunteers are also welcomed to participate in agency fund raisers and administrative assistance.

#### What is Bereavement?

Bereavement is a grief response to the loss of a loved one.



Why is bereavement counseling important? Bereavement counseling helps individuals and families to understand these feelings and go on in life.

What are the negative consequences of unresolved grief?

Some may have difficulty expressing their grief, which can then lead to unresolved grief. Unresolved grief can result in poor job performance, substance abuse, depression and family problems. Unrecognized anticipatory grief can prevent one from fully caring for their loved one as is desired, leading to guilt and feelings of inadequacy before and after the death.
